CHICKEN CHASE I, II, AND III
3-DAY PIONEER RIDE
(Clark State Forest, Henryville, Indiana)
(19 miles North of Louisville, Kentucky)
April 16, 17 and 18, 2010

Sanctioned by: AERC, AHA, AND OAATS

TERRAIN: The trails of Clark State Forest offer a wide variety of terrain and scenery. The first day will consist of a 55/30 mile ride that will have 1 hold away from camp. This will feature the more challenging section of trail. The next two days will stay closer to base camp and have all checks back at camp. Trails are varied with graveled forestry roads to single track. Pads are recommended if doing more than one day.

DIRECTIONS: 19 miles north of Louisville, KY take exit 19 of I-65. (From the north, turn right...from the south, turn left over the interstate.) Go 5.5 miles to Pixley Knob Road. Turn left and go 1.4 miles to Flatwood Road. Turn right and go 1.4 miles, camp will be on the right.(Bill Wilson's Farm)

CAMP: We are on Bill Wilson's Farm. Plenty of horse water and grass. No people water, primitive camping. (FREE CAMPING!!!) Restaurants and gas stations in nearby Henryville or Memphis. Phone....(812) 967-3085....Bill's House.

FOOD: Food will be available on Sat. and Sun. for purchase. We serve a Chicken Dinner on Sat. Night for all riders, regardless of day they ride. Coffee provided a.m.

AWARDS: Completion, Best Condition, First to Finish, Top Ten, Weight Divisions, and also an award for those completing all 3-days on the same horse.

FEE: 25 milers.....\$65.00 (Non-members add \$15.00)
50 milers.....\$80.00 (\$10.00 discount if riding additional day or days)
Juniors.....\$30.00 for either distance

Bridle Tags and Extra Meals are available for purchase. Bridle Tags are \$20 for a yearly tag. I must purchase these ahead of time, for this reason I am asking for pre-entries. (Also helps with planning the meal)These bridle tags are good at all Indiana rides in 2010.
