CAMPING: KNOTT COUNTY RIDING AREA. Camping is primitive. There will be hot showers available at the trailhead and porta potties throughout the camping area. Fresh water is available for self-contained trailers at the trailhead. No dumping station is available. Water trough will be provided for horses. There's also a 25 stall barn for anyone needing stall space. These will be rented on a first come first served basis at a cost of \$10 a night. Bring your own shavings. Renter is responsible for stall cleaning. Camping charges are as follows: \$10 per night per trailer, \$5 per shower. Camping, shower and stall fees to be paid directly to campground.

TERRAIN: The trail system has a wide variety of different types of terrain. It will definitely have something for every rider. Most of the loops will be in wooded areas with trails around 4 ft. wide. There is also some single track as well as wider open stuff. You can expect several stream crossings and areas up on top that will remind you of a scene out of Wyoming that you can open your horse up and enjoy the breathtaking views. There is an abundance of wildlife including elk that will be easily spotted and heard with their bugling that time of year.

VET-IN/START: Vet in begins at 3p Friday for Saturdays ride and 3p Saturday for Sundays ride; Ride will begin at dawn both days.

AWARDS: Completion awards to all who finish meeting ride criteria and following all ride rules. Top 10 awards in the 50 Endurance; Top 5 awards in the 25 Endurance; Top Juniors for both distances.

DIRECTIONS: KNOTT COUNTY RIDING AREA is located approximately 2 miles from Hwy. 80 on Hwy. 1098 near Softshell, KY. Follow signs from Hwy. 80, go 2 miles on Hwy. 1098, turn left onto Elk View Drive at the top of the hill, go 2/10 mile, turn left onto Sutton Memorial Drive, 7/10 mile to the Training Center. Ribbons will mark the entrance to the camp starting Thursday.

ENTRY FEES: **Meal on Saturday included in fee for riders entered in either Saturday or Sundays ride. Extra meal ticket available for purchase at an additional \$10 each.**

50 Miles (Saturday & Sunday) = \$85* ** Juniors 50 Miles = \$45*
25 Miles = \$65* ** Juniors 25 Miles = \$35*
